

Dear Mr. Barnett,

My good friend Charles Koczka, of U.S. customs, suggested I send you a few pictures of my paintings. Enclosed please find just a few examples, of the many old master paintings, which I have re-created over the past 18 years, in exact detail, and most in their original sizes. Also included is a sampling of my own original work, of superstars of the entertainment world. I have danced at the Joffrey, N.Y.C. Ballet, and at the Dutch National Ballet in Amsterdam, during my 30 year career as a ballet dancer, so I have also included a photo of myself as "dancer".

Among the photos please find a picture of my re-creation of Caravaggio's "The Nativity", (I apologize for the poor quality photo). I first saw the A.B.C. CLOSE-UP about this famous stolen masterpiece, over 2 years ago, which was taken from the Oratorio of San Lorenzo in Palermo, Sicily, in 1969. I was so moved by the loss of this great masterpiece, that I immediately, became inspired to re-create the painting as a gift for the church in Palermo. The painting took almost 1 yr. to complete. It is 9ft. high and 7ft. wide. The Cardinal, of Palermo, Sicily, Salvatore Pappalardo, contacted me about the work, and is extremely excited and happy about it. Arrangements are now being for it's transport to Sicily to replace the original, which hung over the alter, since 1609.

Also I have started work on another Caravaggio masterpiece, "St. Matthew and the Angel" 1602, which was destroyed by fire at the Kaiser-Friedrich Museum, during WWII, which I will re-create from archival information from East Germany, from 1909.

PRIMA DONOR

When Noel Baron, a ballerina from La Jolla, California, learned (from an ABC television special) that one of Caravaggio's most famous paintings, *The Nativity*, had been stolen from the Oratorio di San Lorenzo in Palermo, Sicily, she took action. She spent an entire year recreating the nine-by-seven-foot painting (the canvas was so large she had to work in her garage), which she has recently offered to the victimized church. The Cardinal of Palermo, overwhelmed by the offer, has arranged for its transportation to his church where

it will hang over the altar. Baron is now reconstructing another Caravaggio, *St. Matthew and the Angel*, which was destroyed in a fire. "It's my way of returning something precious to the art world," she said. "And to think that my work will hang where Caravaggio's has hung—it's an honor."

Baron's house is filled with more than forty of her canvases: most are copies of the old-master works she prefers, but she has also ventured into the nineteenth century to tackle the work of Albert Bierstadt, J.A.D. Ingres, and Pierre-Auguste Cot (see her version of his 1880 *The Storm*, above). Baron also paints portraits of the people she most admires, like Baryshnikov, Nureyev, and Pavarotti. Her next project is a portrait of Pope John Paul II. Whether copy or original, she works only from photographs. As free wall space disappears, she contemplates opening her own museum where, she says, "People will be able to see memories of the greatest paintings of the world." *Catherine Barnett*

WITH MY EXPERIENCE OF 18 YEARS OF CARAVAGGIO'S WORK, I FEEL THIS IS MY GREATEST ACHIEVEMENT, AND I WISH TO GIVE IT TO YOU PERSONALLY, FOR YOUR PEOPLE TO ENJOY, AND AT LAST REPLACE WHAT WAS TAKEN FROM YOU AND YOURS, IN 1969. I WAS SO MOVED, BY THE STORY OF YOUR LOSS, OF THIS GREAT MASTERPIECE, THAT I DEVOTED ALL OF MY TIME AND ENERGIES, TO HELP HEAL YOUR LOSS OF THE ORIGINAL.

THE PAINTING IS HERE IN MY HOME, FINISHED AND READY FOR YOU TO RECEIVE IT. YOU MAY MAKE ARRANGEMENTS TO HAVE IT PICKED UP HERE AT MY HOME, OR YOU MAY MAKE ARRANGEMENTS TO HAVE THE PAINTING AND MYSELF TRAVEL TO YOUR COUNTRY, SO I MAY PRESENT THE PAINTING PERSONALLY TO YOU, YOUR EMINENCE, WITH RESPECTFULLNESS FOR THIS GREAT RELIGIOUS MASTERPIECE.

I HAVE TRIED UNSUCCESSFULLY FOR THE PAST 3 MONTHS TO HAVE THE MINISTER OF CULTURE, MR. GERLANDO BUTTI, AT THE ITALIAN CONSULATE IN LOS ANGELES, CALIFORNIA, TO ARRANGE A PRESENTATION. HE HAS PRESENTED TO ME A VERY UNSATISFACTORY SOLUTION. HE INFORMED ME TO SHIP THE PAINTING AT MY EXPENSE, AND LATER TRY TO RECOVER A PARTIAL PORTION OF THE SHIPPING COSTS. 




